

## 2026 BOARD OF DIRECTORS



### April Meeting minutes

The Board of Directors held their November monthly Electric Boat Athletic Club Meeting on Tuesday, April 7, 2026, via Teams Call.

Vice President Christine Elliott called the meeting to order at 7:02 PM

1. Are there any matters to be brought forward from the general membership meeting?
  - a. A motion was brought forward from the General Membership meeting to motion to make it EBAC policy that any club leader can apply for one \$50 reimbursement each year for completing any club activity related safety/first aid certification course or clinic. President Jon Carr provided additional information via email:
    - Raising the reimbursement to \$100 per eligible club leader
    - Limit to one benefit per year per leader
    - Adding a limit per club: not to exceed X leaders

Motion was amended to read:

- Raising the reimbursement to \$75 per eligible club leader.
- Clarified limit per club to read: "Not to exceed 6 leaders per club".

Motion was made by Christine Elliott; seconded by Steve Karovolis, All in Favor: Yes. So passed.

- b. President Jon Carr made a motion to permit the use of EBAC media to gauge interest in renewing a previously approved club or league that is no longer active, e.g., prior champion stepped down without a replacement, without further motion at an EBAC meeting where a prospective champion has expressed interest in renewing said club or league. Should there be sufficient interest, prospective champion or other identified champion shall follow EBAC rules in motioning for the reformation of said club or league. This motion was made in support of interest expressed by the former soccer club commissioner Deborah Stewart-VanOrden in reforming the Triathlon Club previously approved in 2016 and which shortly thereafter became inactive when the commissioner departed EB. Deborah currently participates in the soccer club and is also a member of the weekly bike club C ride. She has expressed interest in championing a Triathlon Club pending interest. Some of the C riders in the bike club have already expressed interest in reforming this club.

Motion accepted by Anthony Mikelonis; seconded by: Taylor Allen, All in Favor: Yes.
